2. About GMDC

Gujarat Mineral Development Corporation Limited herein after referred to as GMDC, a Government of Gujarat Enterprise, is a pioneer company in the field of mining for more than five decades, catering to the needs of the minerals and solid fuel for the industries based in Gujarat. GMDC's mining activities are spread all over Gujarat. It is currently dealing in minerals like Lignite, Bauxite, Fluorspar, Ball Clay, Silica sand and Manganese. GMDC has also set up a 250 MW lignite based Thermal Power Station at Nani Chher in Kutch, Wind power plant of 200.9 MW at Maliya, Jodiya, Gorsar, Bhanvad, Bada, Varvala, Rojmal and Solar Power plant of 5 MW at Panandhro Project.

4. General Instructions to bidder

The section aims to provide guidelines/Instructions for Bidders, to be used while submitting the Proposals.

4.1 Cost of Bidding

The Bidder will bear all costs associated with the preparation and submission of its bid and GMDC LTD., will in no event or circumstance be held responsible or liable for these costs, regardless of the conduct or outcome of the bidding process

4.2 Due Diligence

The Bidder is expected to and shall be deemed to have examined all instructions, forms, terms and specifications and other information in this TENDER Document. The bid should be precise, complete and in the prescribed format as per the requirement of the TENDER Document. Failure to furnish all information required by the TENDER Document or submission of a bid not responsive to the TENDER Document in every respect will be at the Bidder's risk and may result in rejection of the bid. GMDC LTD. shall at its sole discretion be entitled to determine the adequacy/ sufficiency of the information provided by the Bidder.

4.3 Clarification of Bidding Documents

GMDC LTD. shall make best efforts to respond to any request for clarification of the TENDER Document. The response/clarification shall to the extent possible be made in writing.

4.4 Amendment of TENDER Document

At any time before the deadline for submission of bids, GMDC LTD may modify the tender Document for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Tender Document by amending, modifying and/or supplementing the same. Any amendments/modifications in the tender document would be displayed on GMDC Web Site//nprocure website and all such amendments shall be binding on the Bidder without any further act or deed on GMDC LTD part. In the event of any amendment, GMDC LTD reserves the right to extend the deadline for the submission of the bids, in order to allow prospective Bidder reasonable time in which to take the amendment into account while preparing their bids. GMDC LTD may at its sole discretion, extend this deadline for submission of bids by amending the bid documents.

4.6 Language of Bid

All Proposals and various documents related to these Proposals should be in English Language. All correspondence between GMDC LTD., and the Bidder would also be in English Language. Supporting Documents and Printed Literature furnished by the Bidder may be in another Language provided they are accompanied by an accurate translation in English Language.

4.7 Late Bids

Any bid received by GMDC LTD., after the deadline for submission of bids prescribed by GMDC LTD., summarily rejected. GMDC LTD. shall not be responsible for any postal delay or non-receipt /non-delivery of the documents. No further correspondence on this subject will be entertained.

4.8 Right to Accept Proposal

GMDC LTD., reserves the right to accept or reject any Proposal, and to annul the Proposal process and reject all Proposals at any time prior to award of contract, without thereby incurring any liability to the affected Bidder or any obligation to inform the affected Consortium of the grounds for such decision.

4.9 Period of Validity of Bids

Bids shall remain valid for 180 days after the date of bid opening prescribed by GMDC LTD and same may be extended unconditionally for further period of 30 days. The Bid of the Bidder shall be considered non-responsive if such Bid is valid for a period less the Bid Validity Period.

4.10 Subcontract

The Successful bidder shall not assign or sub-contract any portion of this work without prior written consent of GMDC.

4.11 Consortium / Joint Venture

Consortium / Joint Venture are not allowed.

4.12 Change in Law

Nothing in this contract shall entitle the Bidder to claim additional payment against the work executed or being executed or likely to be executed upon the change in law by Government of India or State of Gujarat as regards any taxes, liabilities arising out of work contract, judgments of court etc. That nothing under the said laws shall create any additional liability on the GMDC over and above that set out herein. That unforeseen circumstances in the working of the said contract shall not entitle Successful Bidder to abandon or demand additional payment under a different head not originally mentioned herein and hence nothing except what is contained in the present contract shall constitute binding obligations between parties.

4.13 Interpretation

That no communication preceding or following the present TENDER shall have any bearing on the terms and conditions set out herein. That no contract, promise or obligation shall arise out of the said communication, over and above what is set out herein above. That the terms contained herein constitute the entire bargain between the parties and shall not be interpreted in the light of commercial correspondence between the parties.

4.14 GMDC is authorized to take suitable decision and action in case of requirement to amend/alter the contract conditions/quantities of the works/ extension of the contract period/allotment of additional works/revision of the rates of the work etc. if necessary, in the interest of GMDC.

4.15 The Successful bidder shall not change the constitution of the firm/name during the currency of the contract without prior approval of GMDC. Upon such change in constitution and/or name, Supplementary agreement to that effect shall be executed and if the SD is submitted in form of BG/FD than fresh BG in the name and/or constitution shall be submitted failing which necessary action as deemed fit by GMDC shall be taken.



5. Earnest Money Deposit

6. TENDER Processing Fee

If the amount mentioned in the DD/ Digital mode payment is found short, the tender will not be considered for scrutiny and will be out rightly rejected.

7. Security Deposit

7.1 Security Deposit is measure of liquidated damages sustained by GMDC for not performing the contract satisfactorily. Nothing herein above shall disentitle GMDC from claiming the damages actually sustained in the value over and above the Security Deposit.

7.2 The successful bidder shall submit security deposit @ 10% of the total contract value excluding Goods & Service Tax (GST) at within 10 days from the date of issuance of LOI in any one of following form

- Demand Draft in favor of GMDC Limited Payable at Ahmedabad.

OR

- Bank Guarantee issued by banks approved by Govt. Of Gujarat from time to time (except Co-Operative bank) in the form and manner acceptable to GMDC (Govt. GR is annexed at “B” for approved bank). 7.3 It shall be refunded to the Successful bidder, within a period of six months after satisfactory completion of the work and fulfillment of all the terms and conditions of the contract.

7.4 The SD deposited by the Successful bidder may be forfeited if the successful bidder fails to commence of the work within 10 days of acceptance of Letter of Intent.

7.5 Security deposit shall not bear any interest under any circumstances. Security Deposit is a measure of liquidated Damages sustained by GMDC.

7.6 GMDC will reserve the right to recover the charges or the liquidated damages from the Security Deposit in the following circumstances-

- 7.6.1 If the successful bidder or its employees causes any damage or destroy any property belonging to GMDC.
- 7.6.2 The shortfall amount of all compensations, penalties and other sums of money payable by the successful bidder or recoveries to be made under the terms of this contract which is due but not paid by the successful bidder in full, etc.
- 7.6.3 Any other dues on account of statutory compliance.

9. Eligibility and Qualification Criteria of Bidder

9.1 Experience

9.1.1 The Bidders should have following minimum experience of having successfully completed similar works during last 7 (seven) years ending on last day of Sept 2024 (i.e. period from 01.07.2017 to 30.06.2024)

A. Three similar completed works each having amount of Rs 9,60,000/- (Rupees Nine Lacs sixty thousand only) during last 7 (seven) years.

OR

B. Two similar completed works each having amount of Rs 12,00,000/- (Rupees Twelve Lacs Only) or more during last 7 (seven) years

OR

C. One similar completed work having amount of Rs 19,20,000/- (Rupees Nineteen Lacs twenty thousand only) or more during last 7 (seven) years.

Similar works means the Bidders should have experience of providing services for Forecasting, Scheduling, Metering and energy accounting work according to guideline of GERC/CERC regulations 1 of 2019 & any Amendments /alterations /modification / Replacements thereto, with respect to client's requirement in any project or any industry and carried out or being currently carrying out under the single LOI/Work Order/Agreement.

Bidder shall submit the details of work completed in FORM PC as provided in the Tender Document. Separate year wise Statement of experience with work orders and work executed certificates duly certified by the certificate issuing authority shall be submitted as supporting documents.

9.2 Financial

9.2.1 Bidder must have an average positive Net Worth for the last three financial years i.e. 2021-2022, 2022- 23 and 2023-24.

9.2.2 Bidder must have a Minimum Average Annual Turnover of 7,20,000/- (Rupees Seven Lacs Twenty Thousand Only) for financial year of 2021-2022, 2022- 23 and 2023-24

9.2.3 A certificate from Chartered Accountant regarding financial capacity shall be submitted as per format provided in FORM PC of the TENDER Document.

9.3 Blacklisting of the Bidder

The Bidder or its directors have not been blacklisted by any Government Organization, nor should any litigation be pending against any of them. The Bidder will submit a declaration to

this effect as per the format provided in FORM PD of the TENDER Document. If at any time

such declaration is found false, the bid will be rejected or if the contract work is already awarded, it will be terminated forthwith without payment of any compensation and the EMD/SD will be forfeited.

10. Scope of Work:

Under the scope of this contract, the successful bidder is required to provide services for Forecasting, Scheduling, Metering and energy accounting work according to guideline of GERC/CERC regulations 1 of 2019 & any Amendments /alterations /modification / replacements thereto, for GMDC's various wind sites. (mentioned in the Table-A)

10.1 Payment security to SLDC: The Successful Bidder required to Submit BG / LC for Payment security at SLDC for DSM as and when declared and updated by SLDC (at present payment security in form of BG/LC as published by SLDC is at the rate of Rs. 3354 per MW w.e.f 1.08.2024)

10.2 Reimbursement of DSM: The Successful Bidder shall have to pay DSM declared by SLDC every week as per forecasting and scheduling work as per the latest guideline of GERC/CERC and amendment 1 of 2019 thereof, and GMDC will reimburse the same after submission of payment proof paid to SLDC.

- **DSM (Deviation Settlement Mechanism) means the payment of Deviation charges to the SLDC.**
- **Whereas Deviation means the total actual injection of energy minus total schedule generation.**
- **In the event of actual generation of a wind generating station or a pooling station, as the case may be, being less or more than the scheduled generation, the deviation charges for shortfall or excess generation shall be payable.**

10.3 Forecasting capabilities

- i. Bidder must be procuring weather data either from international service provide or from national agencies for wind power forecasting and scheduling activities
- ii. Bidder must have experience of working in the Indian terrain / Software being used by the bidder must have the capability to integrate Historical and real- time wind generation data for the wind power farm
- iii. A dedicated forecast of large rapid changes in wind generation for managing power system security.
- iv. A tailored forecast to minimize wind plant revenues loss / reduce under wind forecasting obligation.
- v. Integration of location and site related details of the wind site / Park. Integration of SCADA data on real time basis from the Developer / Generator

10.4 Software capabilities

- i. User-friendly online web based application for wind power forecasting and scheduling.
-
- ii. High end server to collect the data
 - iii. Integration of the forecast from the Forecasting Service Provider / own forecast and conversion of the same to schedules as applicable in the 96 time- block frame with 15 minutes interval abiding specific state regulations as prescribed.
 - iv. Integration of location and site related details of the wind site / Park. Integration of SCADA data on real time basis from the Developer / Generator in the software
 - v. Automatic submission of schedules to the concerned SLDC or to the Generator as applicable
 - vi. Flexibility and adaptability in case of any issues
 - vii. Ability to have manual intervention if required during submission of schedules.
 - viii. To provide analysis / summary report for weekly/Monthly/Yearly based on forecasted / scheduled vs. actual wind generation data by using SCADA data. The provision in module should be in such way that any kind and any format of data summary can access
 - ix. Software shall have ability generate and submit revisions at predefined
 - x. Intervals as per regulations.
 - xi. Capability to store Historical Data.

10.5 Schedule Management

- i. Compilation of schedules with all revisions within a designated time frame (as submitted by Stakeholders or as per regulation for submission to SLDC).
- ii. Co-ordination with SLDC control room for any Scheduled/real time update on
- iii. Grid downtime (optional).
- iv. Co-ordination with wind Park operator/stakeholders for any downtime or feeder tripping at local pooling station, if the same is not considered while submission of Day ahead or Intraday revision to an aggregator.
- v. To gather actual generation data from Developers/ Turbines /DISCOM. (Access has to be provided by Developer/wind Park Owner).
- vi. Analysis of Actual vs. Schedule Data and subsequent effects.
- vii. To provide online monitoring through web based software application. The IP rights for the said application shall remain with the service provider
- viii. To provide online monitoring to visualize deviations on real time daily basis.

10.6 Minimum Hardware capabilities:

As per the latest Guideline of GERC/CERC

10.7 Detail Scope of Services:

The Scope of the services shall be on the basis of the successful Bidder's responsibility, completely covering all the services specified under the accompanying Technical Specifications. It will include among others as specified therein the following: -

- QCA shall prepare and send Forecasting and Scheduling generation reports as per extant regulations (GERC/CERC) for Forecasting, Scheduling, Deviation Settlement mechanism and related matters.
- QCA shall provide dashboard/mobile app access for real time monitoring, for viewing report etc.
- To provide user friendly online web-based application for wind power forecasting and scheduling.
- To provide real time, day ahead forecast/schedule value and actual value in 96-time blocks (of 15 minutes each) in MW with graphical trend.
- To coordinate with our windmills O & M contractor to provide require real time data at agreed point is in bidder's scope.
- To provide analysis / summary report for weekly/ monthly/ yearly, based on forecasted / scheduled vs. actual wind generation data by using SCADA data. The provision in module should be in such way that any kind and any format of data summary can access. All required hardware along with ABT meter (15-minute time cycle) are in the bidder's scope and bidder should quote price considering all required software as well as hardware.
- To provide daily forecasts/schedules based on the historical wind data, actual turbine generation data collected from developer's server (10 min SCADA data).
- To update and provide revised forecast /schedule 16 times or more as per regulations based on actual weather and onsite real time wind and turbine data.
- To maintain the necessary back-ups of forecasted data at own premises and provide to GMDC as and when needed.
- To do immediate communication with related O & M contractor about non availability of data due to instrumentation failure or malfunction. It is bidder's liability to update the data by communicating with O & M contractor.
- Bidder shall be flexible to implement CERC /GERC regulation changes as and when takes place.

- Dispatch of Schedule to SLDC.
- To collect turbine availability data (under maintenance or under breakdown) from O & M contractor on daily basis and incorporate in forecasting model for accurate forecasting.

- Bidder's own infrastructure to dispatch the schedules to SLDC.
 - To maintain accounting of energy generation and any UI charges applicable to each generator as per SLDC guidelines; Daily, Weekly report generation as per the client requirement and format.
 - To be responsible for revising the machine availability based on information provided by the O & M contractor and expected generation based on the changes in machine availability from time to time and incorporates in subsequent revisions to SLDC.
 - Bidder shall have web portal to upload the non-availability of WTGs for better and accurate scheduling.
 - Bidder shall be reconsidered at time of implementation as per latest CERC/GERC Orders/Regulations) as and when applicable.
 - Management of UI charges account, collection of UI charges from Individual generator as per calculation given by SLDC, depositing UI charges to SLDC.
 - To undertake the apportioning of deviated energy/applicable charges as per settlement mechanism.
 - To undertake deviation settlement mechanism with SLDC on behalf of GMDC, GMDC will be reimbursed DSM payment within 10 days after submission of invoice with payment proof paid to SLDC.
 - To calculate and do the visioning work for commercial settlement of all the charges applicable to GMDC including payment to regional/ State UI/DSM Pool accounts through the concerned RLDC/SLDC on behalf of GMDC; GMDC will reimburse DSM payment within 10 days after submission of payment proof made to SLDC by Bidder.
 - To undertake de-pooling of payments receivable or payable as applicable on behalf of GMDC from the regional/State UI/DSM Pool and settlement with individual generators
 - To undertake commercial settlement of any other charges on behalf of GMDC as may be mandate from time to time.
 - To Liaise with SLDC on behalf of GMDC to settle any disputes or complaints related to deviation, scheduling or forecasting.
 - Qualified Co-ordinating (QCA) Agency should be register with SLDC/Gujarat and shall follow the GUJARAT STATE ELECTRICITY REGULATORY COMMISSION (Forecasting, Scheduling, Deviation Settlement and related matters of renewable

energy sources) regulations in existence and amended from time to time.

- Qualified Co-ordinating Agency (QCA) should meet the Qualifying criteria of SLDC (Forecasting, Scheduling, Deviation Settlement and related matters of renewable energy sources) regulations in existence and amended from time to time.

-
- It is the responsibility of successful bidder to get the majority in every Sub-station/pooling station and also to get the concerned letter from SLDC
 - It is the responsibility of successful bidder to get the NOC from previous QCA at each and every sub-station of GMDC's site

11. Duration and Quantity of Work:

The duration of the contract for providing services for Forecasting, Scheduling, Metering and energy accounting work according to guideline of GERC/CERC regulations & any Amendments /alterations /modification / replacements thereto as per GERC regulation 1 of 2019 for GMDC's various winds site will be for a period of 2 year from the date of receipt of LOI. However, period of contract may be extended for 2 years on the same terms and conditions of the contract subject to the requirement, entire satisfaction of GMDC and mutually acceptance to both the parties.

12. Liquidated Damages (LD):

12.1 If the successful bidder fails to Start the work at any Wind Site as per the scope of work within 30 days from the acceptance of LOI and the reasons for the same are attribute to the successful bidder, LD will be levied at the rate of 0.5% of Total Average Contract Value per week and maximum LD will be 05 % of the Total Contract value. (on Annual Service Charge)

12.2 During execution of contract if the successful bidder fails to deliver following criteria up to satisfaction of GMDC, L.D will be imposed on RA bill at the rate 05 % of total Average Contract value per week.

12.2.1 Timely submission of FC & SCH to SLDC

12.2.2 Timely submission of DSM charges

Note: maximum L.D. will be levied 10 % of the Total Contract value

13. Goods & Service Tax:

13.1 All bidders are required to submit their GST number and date in the bid. Bid received from

unregistered bidder will not be considered and out rightly rejected.

- 13.2 Bidders are requested to quote their rates without GST. GST will be paid/adjusted/reimbursed to the Successful bidder as per prevailing rates and rules to the extent directly related to the services rendered by the Successful bidder under the said contract subject to production of documentary proof and Successful bidder will mention the GST amount separately in the invoice/bill along with SAC Code under GST.

14. Payment:

- 14.1 The Successful bidder shall submit invoice for the work of services for Forecasting, Scheduling, Metering and energy accounting work according to guideline of GERC/CERC regulations & any Amendments /alterations /modification / replacements thereto as per GERC regulation 1 of 2019 for GMDC's various winds site executed every quarter of the completion of the period for the works. Payment shall be processed after execution of the works schedule only.
- 14.2 Invoice shall be submitted every week to the office of the I/C General Manager (Renewable Energy) with following documents:
- 14.2.1 All the data of forecasting work,
- 14.2.3 Compliance of all law relevant with the said work carried out by Successful Bidder such as Labour and Factories Act etc.
- 14.2.4 Payment shall be made as per actual work carried out by the Successful bidder only.
- 14.2.5 Service charge payment: Service Charge shall be calculated based on the DSM penalty on pooling station in Paisa/KWH on Quarterly basis, i.e. Three-month total average (Total DSM in paisa for 3 months/Total Actual Generation (Injection/Drawal) in KWH for 3 months as declared by SLDC). Further there will be no payment is case DSM is more than 4.00 paisa per KWH in the particular quarter in a pooling station.

15. Mode of Payment:

The bills submitted at the office of I/C General Manager (Renewable Energy) will be processed within 30 days considering the following deductions.

- 15.1 Income tax as per provision of Income Tax Act, and other Taxes (and surcharges) applicable in force from time to time.
- 15.2 Liquidated damages,
- 15.3 Other deductions, if any.

16. Evaluation of Bids:



16.1 The entire Bid shall be evaluated based on Quality Cum Cost Based System (QCBS) methodology as prescribed in subsequent clauses.

16.2 The Bid evaluation shall be first on Technical Score of max 100, based on various scoring criteria outlined as per following Table.

16.3 GMDC will examine the Bid to determine whether the bid is complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed, and whether the Bid is generally in order.

16.4 In no case, a Bidder shall have the right to claim to be the Successful Bidder for its Bid.

16.5 Evaluation of both Techno-Commercial (un-priced) bids and priced bids shall be done separately.

16.6 Selection of successful bidder shall be done as below:

16.6.1 Technical bids will be opened after verification of receipt of payment towards TENDER Fee and EMD.

16.6.2 After, meeting Eligibility Criteria, (PQR) Responsiveness, Preliminary scrutiny of the Bid, the Technical Bid Evaluation shall be carried out.

16.6.3 Technical Proposal will be evaluated for eligibility on the basis of Bidder's experience, presentation and financial capability. Scoring of Technical Proposals would be done only for the Eligible Bidders.

16.6.4 A minimum of 70 marks out of 100 should be scored in the Technical Evaluation for the bid to be declared technically qualified.

16.6.5 All technical qualified bidders shall be ranked from highest to lowest on the basis of their Technical Score (TS).

16.6.6 The Financial Bids of only those bidders who have obtained a technical score of 70 or more shall be opened.

16.6.7 The financial evaluation of the proposal will be carried out after determining whether the Financial Proposals are complete, qualified and unconditional.

16.6.8 The lowest financial proposal (LFP) will be given a financial score (FS) of 100 points. The financial scores of other proposals will be computed as follows:

Wherein, F = Amount of Financial Proposal of the Bidder

LFP = Lowest financial proposal

16.6.9 Final Evaluation Proposals will finally be ranked according to their Technical Score (TS) and Financial Scores (FS) as bellow:

$$CS = \text{Technical Score (TS)} \times 0.70 + \text{Financial Score (FS)} \times 0.30$$

Where CS is the combined score.

16.6.10 The contract will be awarded to the bidder who scores highest (H1) in Combined Score (CS).

17. Negotiation:

It is absolutely essential for the successful bidders to quote the lowest price at the time of making the offer in their own interest. GMDC, however, will have the discretion to choose to enter into any price negotiations or not.

18. Acceptance of Offer:

- 18.1.1 GMDC, on acceptance of the offer, will issue Letter of Intent to the successful bidder; who will be required to confirm its acceptance of the LOI within 7 days from the date of receipt. If Successful bidder does not accept the LOI within stipulated time period, the amount of the EMD paid will be forfeited and necessary further actions may be initiated as may be deemed fit by the GMDC.
- 18.1.2 The Successful bidder shall have to submit the Security Deposit with 7 days from the date of acceptance of LOI. The Successful bidder shall submit the Security Deposit in the manner prescribed in this TENDER Document. In case of failure to submit the security deposit, the amount of EMD will be forfeited and necessary further actions may be initiated as may be deemed fit by the GMDC.
- 18.1.3 The successful bidder, along with the payment of Security Deposit, shall have enter into a contract/ agreement with the GMDC on appropriate Stamp Paper (to be provided by the Contractor) in token of acceptance of the terms and conditions of the contract, within 30 days from the acceptance of LOI.

19. Intellectual Property Rights (IPR):

Confidentiality of Data and Documents: All Intellectual Property Rights (IPR) of data collected as well as the deliverables produced shall remain with the GMDC. All knowledge and information, which may be acquired during the assignment, shall be for all times and for all purposes, regarded as strictly confidential and held in confidence, and shall not be directly or indirectly disclosed to any person whatsoever, without the explicit written permission of GMDC

20. Statutory Obligations:

- 20.1 If any amount becomes payable by GMDC as a result of any claim or application in terms of the provisions or non-compliance of provision of the any Acts and the Rules and Regulations, By-laws or the Orders made there under, applicable from time to time, such amounts shall be recoverable from the Successful bidder for which GMDC will not be responsible for any compensation.

20.2 That the Successful Bidder would obey with all applicable laws and maintain all such necessary records as necessitated under such enactments.

20.3 The Successful bidder shall also indemnify the GMDC against any claims, compensations, damages, loss, liquidated damages etc. for breach and / or non-fulfillment of the prevailing Rules and Regulations and other statutory provisions in force from time to time and applicable to the work during the currency of contract.

20.4 The Successful bidder shall comply with other statutory provisions of Law. The Successful bidder shall comply with all applicable laws, ordinances, approved standards, rules and regulations

21. Notice:

Written notice shall be deemed to have been duly served if delivered to the individual or to Successful bidder or to the Signing Authority of the GMDC from whom it is intended, or if delivered at or sent by mail or post, to the last business address known to him who gives the notice.

22. Canvassing Not Permitted:

22.1 Bidder should not canvass their offer personally or otherwise by approaching the Chairman or the Member of GMDC. If any Bidder wants to make any representation regarding his offer, he should write to the I/C General Manager (Renewable Energy), if he desires, but personal and oral representations are not permitted.

22.2 In spite of the above clear instructions, any Bidder is found to canvass his offer or against his competitor's offer through personal approach to the competent authority or the officials of GMDC, their offer will be rejected without assigning any reason and the firm even is blacklisted.

23. Bankruptcy:

If the Successful bidder commits an act of Bankruptcy or goes into liquidation except for construction purposes, or if its business is carried on by a receiver, such receiver, liquidator or any person in whom the contract may become vested shall forthwith give notice thereof in writing to GMDC and in reasonable time during which he shall take all reasonable steps to prevent stoppage of performance of the contract, have the option of carrying out the contract subject to his or their providing such guarantees as may be required by GMDC but not exceeding the value of the work for the time being remaining unexecuted.

In the event of stoppage of performance under the contract, the period of option under this clause

shall be decided by GMDC considering the situation, provided that the above option is not exercised, GMDC may terminate the contract by serving notice in writing to the Successful bidder. The power and provision so reserved to GMDC on taking of the work out of the Successful bidder's hands shall apply as far as they may be when the contract is so terminated.

24. Termination Of Contract:

If at any time during the currency of this contract, if any breach occurs due to the reasons attributed to the Successful bidder, GMDC shall be at liberty to terminate this contract without assigning any reasons, whatsoever, for such termination and any losses and/or damages occurring due to such termination shall be borne by the Successful bidder. GMDC shall be entitled to forfeit Security deposits as Liquidated damages.

25. Governing Law:

This TENDER and subsequent Contract shall be construed and interpreted in accordance with and governed by the laws of India.

26. Arbitration:

All questions, disputes, differences whatsoever which may at any time arises between the parties to this TENDER and subsequent contract in connection with the TENDER and subsequent contract or any matter arising out of or in relation thereto, shall be referred to Sole Arbitrator as per the provisions of Arbitration and Conciliation Act, 1996 and subsequent amendment thereto and the venue of arbitration proceedings shall be at Ahmedabad only. The Language of the Arbitration shall be in English only.

27. Jurisdiction:

The matter related to any dispute or difference arising out of this TENDER and subsequent contract shall be subject to the exclusive jurisdiction of Court at Ahmedabad only.

28. Non-Fulfillment of Terms and Condition of The Contract:

28.1 If the Successful bidder fails to carry out the work as per terms and conditions of the contract to the satisfaction of the GMDC, GMDC shall be entitled to forfeit the security deposit paid by the Successful bidder. This, however, shall not absolve the Successful bidder from his obligation to fulfill the contract. In such event, the GMDC shall have a right to complete and / or to get the work completed at the cost & risk of the Successful bidder and the Successful bidder shall be responsible to pay such cost incurred by the GMDC to complete the work and / or to get the work completed.

28.2 Likewise, if the Successful bidder does not fulfill the terms and conditions of the contract and does not carry out the work up to the entire satisfaction of GMDC, GMDC has the right to forthwith terminate the contract at its sole discretion, without assigning any reason, Under such events, the GMDC shall be entitled to forfeit the security deposit paid by the Successful bidder and the GMDC shall have a right to complete the work and / or to get the work completed at the risk and cost of the Successful bidder.

28.3 For any reasons, if it is required, the GMDC reserves rights to cancel, terminate, amend and / or alter the contract and / or bifurcate and / or reduce the contract work at any time without giving any notice or reason to the Successful bidder and without incurring any responsibility. For such cases, Successful bidder shall have to take away his labour, tools, tackles, machinery, equipment etc. and shall leave the site at once or shall have to carry out the instructions of the GMDC.

29. Foreclosure:

In case of any necessity arising due to local working conditions or any unforeseen reason not in the control of the GMDC or any reason whatsoever GMDC shall be at liberty to Foreclose of the contract without assigning any reasons or notice there for.

30. Force Majeure:

30.1 Force majeure is herein defined as any cause which is beyond the control of the Successful bidder or the GMDC as the case may be which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affect the performance of the contract, such as:

30.2 Natural phenomena such as flood, draughts Cyclone, earthquake and epidemics, declaration of war.

30.3 Acts of any government, including but not limited to war, declared or undeclared priorities, quantities, embargoes, providing either party shall within fifteen (15) days from the occurrence of such a cause notify the other in writing of such cases.

30.4 The Successful bidder will advise, in the event of his having resort to this clause by a registered letter duly certified by the statutory authorities, the beginning and end of the cause of delay, within fifteen days of the occurrence and cessation of such Force Majeure condition. In the event of delay lasting over two months, if arising out of Force Majeure, the contract may be terminated at the discretion of the GMDC.

30.5 For delay arising out of Force Majeure, the Successful bidder will not claim extension in completion date for a period exceeding the period of delay attributable to the causes of force

- Majeure and neither company nor the Successful bidder shall be liable to pay extra costs (like increase in rates, remobilization, advance, idle charges for labour and machinery etc.) provided it is mutually established that the Force Majeure conditions did actually exist.
- 30.6 If any of the Force Majeure conditions exists in the place of operation of the Successful bidder even at the time of submission of bid, he will categorically specify them in his bid and state whether they have been taken into consideration in their quotations.

30.7 The Successful bidder of the GMDC shall not be liable for delays in performing his obligations resulting from any force majeure cause as referred to and/ or defined above. The date of completion will, subject to hereinafter provided, be extended by a reasonable time given though such cause any occur after Successful bidder's performance of his obligations has been delayed for other causes
